#### RULE 29 FOR MOLOKAI AND LANAI

By this Order, the Public Utilities Commission ("Commission") clarifies Order No. Order No. 38038 and its treatment of the Maui Electric Tariff Rule 29.1

### BACKGROUND AND RELEVANT PROCEDURAL HISTORY

On April 9, 2020, the Commission issued Order No. 37070, commencing Phase 2 of the Community Based Renewable Energy ("CBRE") program.<sup>2</sup>

On October 25, 2021, the Commission issued Order No. 38038, directing Hawaiian Electric to file its final requests for proposals ("RFPs") and supporting documents for Molokai and Lanai by November 4, 2021.

Order No. 38038 stated that "final RFPs and supporting documents for Molokai and Lanai will be approved automatically 10 days after they are filed, unless the Commission orders otherwise."4

On November 4, 2021, Hawaiian Electric filed its final RFPs Molokai and Lanai, and Maui Electric Tariff Rule 29 ("Rule 29"). Hawaiian Electric asked the Commission to approve

Rule 29 "with the proviso that none of the phase two provisions for Maui island are applicable until further order from the Commission." Hawaiian Electric explains that:

a limited Rule 29 can be approved for Maui Electric now to allow the Molokai and Lanai RFPs to proceed expeditiously and can be amended at a later time to incorporate any modifications, with respect to RFPs on the island of Maui. In addition, to further address potential uncertainty, Rule 29 has been amended to note that it only opens Phase 2 for the islands of Molokai and Lanai, and the opening of Phase 2 for the island of Maui will occur upon subsequent Commission order, as only the Molokai and Lanai RFPs are proceeding at this time.<sup>7</sup>

On November 15, 2021, Order No. 38038's automatic approval deadline elapsed without further Commission action, thereby approving the Final Molokai and Lanai Filings.

II.

#### DISCUSSION

The Commission wishes to clarify that it agrees with Hawaiian Electric's approach to approve Rule 29 with the proviso that none of the Phase 2 provisions for Maui island will be applicable until further order from the Commission. The Commission believes this will allow CBRE Phase 2 to proceed on Molokai and Lanai now, and allow the additional time necessary to finalize


CBRE Phase 2 for the remaining islands. Therefore, the Commission clarifies that Order No. 38038's automatic approval provision includes the Maui Electric Tariff Rule 29 with the proviso that none of the Phase 2 provisions for Maui island will be applicable until further order from the Commission. In all other respects, the Order No. 38038's automatic approval provision remains in full effect.

III.

#### ORDERS

#### THE COMMISSION ORDERS:

1. The proposed Maui Electric Tariff Rule 29 is approved with the proviso that none of the Phase 2 provisions for Maui island will be applicable until further order from the Commission.



2. In all other respects, the Order No. 38038's automatic approval provision remains in full effect.
